Unsolved Traffic Homicide Investigations

The Daytona Beach Police Department is offering a \$1000.00 reward for information leading to the arrest of the person responsible for anyone of these accidents.

On 10/11/2006 @ 1931 hours

Pedestrian **Henry Carroll Jr.** was crossing South Nova Road, eastbound. He was struck in the center northbound lane. Witnesses described the vehicle as a black Nissan or Mitsubishi two door with dark tinted windows. The vehicle was traveling in the center lane. The vehicle only stopped for a few second before traveling northbound to West International Speedway Blvd and then turning eastbound. Carroll was pronounced deceased at the scene.

On 05/26/2007 @ 2209 hours

THI- Pedestrian/Victim was crossing S. Atlantic Ave. (approx. 150 ft. south Of Poinsettia, a southbound vehicle struck the victim with it front end. The vehicle turned off the headlights and continued southbound on S. Atlantic Avenue. The victim **Cynthia Dudley** W/F 07/26/48 was pronounced deceased at Halifax Medical Center. Vehicle is described as a white mid 90's medium vehicle (possibly a Pontiac Grand Am) with front-end damage.

On 11/29/2007 @ 1422 hours

Motorcyclist was traveling southbound on Halifax approaching Seabreeze. A vehicle northbound on Halifax turned in front of the motorcyclist and impact was made. The motorcyclist died from the injuries. **Hal Jerome Warlick** W/M 10-15-

Three pedestrians were standing in the median attempting to cross from east to west at the above location. A vehicle being driven by a B/M traveling northbound on Ridgewood struck the pedestrians. **Fredrick L. Cook** 526 Fulton Street died enroute to Halifax Hospital, Michael Thompkins and John Baldwin received non-life threatening injuries. The suspected vehicle is a white four door vehicle possibly a Buick or Nissan product was being driven by a B/M the vehicle should have a broken windshield.
