### Speed Weeks 2014

#### **Daytona International Speedway property, "Turn 4 Tunnel" access from Bill France Blvd. and International Speedway Blvd. restricted to all vehicle traffic**

All traffic attempting to access the Daytona International Speedway property, "Turn 4 tunnel" from International Speedway Boulevard at Bill France Boulevard will be sent east on International Speedway Boulevard to Midway Boulevard, then right (south) on Midway Boulevard to Richard Petty Boulevard and onto Daytona International Speedway property/ "Turn 4 Tunnel" access.

#### **Saturday - February 15, 2014 (ARCA 200 / Bud Shootout)**

##### ***Before the Race:***

**Williamson Boulevard:** Williamson Boulevard between Beville Road (SR-400) and West International Speedway Boulevard (US-92) will not be restricted but there will be heavy congestion.

**Richard Petty Boulevard:** Petty Boulevard will not be restricted.

**On Property Parking :** The only on property parking will be reserved for tower parking only through gate 26. Gate 25 will be closed to all vehicular traffic and accepting pedestrian traffic only. Handicapped parking at turn one plaza, The ISC facility at 92 and Nascar Drive, Volusia Point at 92 and Bill France, and Gate 50 on back side of speedway.

##### ***After the Race:***

**Bill France Boulevard:** Access on Bill France Boulevard from Mason Avenue to Clyde Morris Boulevard will not be restricted.

**Jimmy Ann Drive:** Jimmy Ann Drive from the Volusia Mall to the Mason Avenue intersection will be normal two-way traffic.

**Richard Petty Boulevard:** Petty Boulevard will be normal two-way traffic to Clyde Morris Boulevard. Race fans exiting Richard Petty must turn right onto Clyde Morris to Beville Road where they may then go east or continue south on Clyde Morris Boulevard.

**Fentress Boulevard:** Fentress will be normal two-way traffic between Bayless and Mason Avenue. Southbound turns onto Fentress will be restricted at Mason Avenue, however, business traffic will be accommodated.

**Mason Avenue:** Mason Avenue will be two-way traffic from the Bill France intersection to Williamson Boulevard.

**Williamson Boulevard:** Williamson Boulevard will be two-ways north from Mason Avenue to L.P.G.A. Boulevard.

**Dunn Avenue:** Dunn Avenue will be restricted to local traffic only between Clyde Morris Boulevard and Williamson Blvd.

**Clyde Morris Boulevard:** Southbound Clyde Morris Boulevard will be restricted at LPGA Boulevard. Northbound Clyde Morris Boulevard will be restricted at Jimmy Ann Drive. Northbound Clyde Morris Boulevard will be forced south (left) on Bill France.

## **Thursday - February 20, 2014 (Gatorade Duel)**

### ***Before the Race:***

**US-92:** Eastbound vehicles on US-92 from Deland, I-4 and I-95 that are ***NOT*** going to the Speedway are encouraged use Beville Road or L.P.G.A. Boulevard.

**Richard Petty Boulevard:** Petty Boulevard will be normal two-way traffic from Clyde Morris to Midway Boulevard.

**Williamson Boulevard:** Williamson Boulevard between Beville Road (SR-400) and West International Speedway Boulevard (US-92) will not be restricted but there will be heavy congestion.

**On Property Parking :** The only on property parking will be reserved for tower parking only through gate 26. Gate 25 will be closed to all vehicular traffic and accepting pedestrian traffic only. Handicapped parking at turn one plaza, The ISC facility at 92 and Nascar Drive, Volusia Point at 92 and Bill France, and Gate 50 on back side of speedway.

## **After the Race:**

( **\*\* These one-way patterns may be in effect from 1:30 p.m. until approximately 10:00 p.m. \*\*** )

**Bill France Boulevard:** Bill France Boulevard may be ONE-WAY NORTH from West International Speedway Boulevard to the Mason Avenue intersection. Access on Bill France Boulevard from Mason Avenue to Clyde Morris Boulevard will be restricted.

**Mason Avenue:** Mason Avenue may be ONE-WAY WEST from the Bill France intersection to Williamson Boulevard.

**Williamson Boulevard:** Williamson Boulevard, north of Mason Avenue, may be ONE-WAY NORTH from the Mason Avenue intersection to L.P.G.A. Boulevard. Access to I-95, I-75, I-4, Ocala and US-1 (north) can be reached via Williamson Boulevard. Williamson Boulevard, south of Mason Avenue, will consist of normal north and southbound traffic lanes to Bayless. Williamson, south of Bayless will be closed to southbound traffic. There will be no access to Williamson Boulevard southbound from west International Speedway Boulevard.

**Jimmy Ann Drive:** Jimmy Ann Drive will be normal two-way traffic.

**Dunn Avenue:** Dunn Avenue will be restricted to local traffic only between Clyde Morris Boulevard and Williamson Blvd.

**Clyde Morris Boulevard:** Southbound Clyde Morris Boulevard will be restricted at LPGA Boulevard. North bound Clyde Morris Boulevard will be restricted at Jimmy Ann Drive. Northbound Clyde Morris Boulevard will be forced south (left) on Bill France.

**Richard Petty Boulevard:** Petty Boulevard may be ONE-WAY EAST to the Clyde Morris intersection. Race fans exiting Petty Boulevard must turn right onto Clyde Morris Boulevard. Central and South Central Florida traffic will be encouraged to continue south on Clyde Morris Boulevard to Dunlawton Avenue. Traffic will turn right on Dunlawton Avenue to access I-95, north to I-4 or south to the Bee-Line.

**Fentress Boulevard:** Fentress Boulevard will be normal two-way traffic between Bayless and Mason Avenue. Southbound traffic from Mason Avenue will, however, be restricted to business access only.

**Thames Road:** All traffic exiting the Volusia Square Mall will be sent south on Thames to Williamson, where it will be directed south to access the Interstate System.

**L.P.G.A. Boulevard:** Traffic eastbound on L.P.G.A. Boulevard from Speedway Boulevard will experience lengthy delays beyond Champions Drive.

**US - 92:** Westbound traffic on West International Speedway Boulevard desiring to go west should utilize Beville Road to avoid heavy traffic in the vicinity of the speedway.

**I - 95:** It may be necessary to restrict northbound traffic from exiting at L.P.G.A. and SR-40 from I-95. Motorists will be allowed to exit at the next exit, which is US-1 at National Gardens. Traffic wishing to go to Daytona Beach should utilize US-1 southbound. Traffic wishing to go to A1A should take US-1 to SR-40 in Ormond Beach, and go east over the Granada Bridge to A1A. Motorists wishing to travel west on SR-40 can exit at US-1 and re-enter I-95 and travel south to SR-40.

### **Friday - February 21, 2014 (Next Era Energy Resources Truck Series)**

#### ***Before the Race:***

**US-92:** Eastbound vehicles on US-92 from Deland, I-4 and I-95 that are **NOT** going to the Speedway are encouraged use Beville Road or L.P.G.A. Boulevard.

**Williamson Boulevard:** Williamson Boulevard between Beville Road (SR-400) and West International Speedway Boulevard (US-92) will not be restricted but there will be heavy congestion.

**Richard Petty Boulevard:** Petty Boulevard will not be restricted from Clyde Morris to Midway Boulevard. Normal two way traffic

**On Property Parking :** The only on property parking will be reserved for tower parking only through gate 26. Gate 25 will be closed to all vehicular traffic and accepting pedestrian traffic only. Handicapped parking at turn one plaza, The ISC facility at 92 and Nascar Drive, Volusia Point at 92 and Bill France, and Gate 50 on back side of speedway.

#### ***After the Race:***

**Bill France Boulevard:** Access on Bill France Boulevard from Mason Avenue to Clyde Morris Boulevard will be restricted.

**Jimmy Ann Drive:** Jimmy Ann Drive from the Volusia Mall to the Mason Avenue intersection will be normal two-way traffic.

**Richard Petty Boulevard:** Petty Boulevard will be normal TWO-WAY traffic to Clyde Morris Boulevard. Race fans exiting Richard Petty must turn right onto Clyde Morris to Beville Road where they may then go east or continue south on Clyde Morris Boulevard.

**Fentress Boulevard:** Fentress will be normal two-way traffic between Bayless and Mason Avenue. Southbound turns onto Fentress will be restricted at Mason Avenue, however, business traffic will be accommodated.

**Mason Avenue:** Mason Avenue will be normal two-way traffic from the Bill France intersection to Williamson Boulevard.

**Williamson Boulevard:** Williamson Boulevard will be normal traffic north from Mason Avenue to L.P.G.A. Boulevard.

**Dunn Avenue:** Dunn Avenue will be restricted to local traffic only between Clyde Morris Boulevard and Williamson Blvd.

**Clyde Morris Boulevard:** Southbound Clyde Morris Boulevard will not be restricted at LPGA Boulevard. Northbound Clyde Morris Boulevard will not be restricted at Jimmy Ann Drive. Northbound Clyde Morris Boulevard will be forced south (left) on Bill France.

## **Saturday - February 22, 2014 (Nationwide Series)**

### ***Before the Race:***

**US-92:** Eastbound vehicles on US-92 from Deland, I-4 and I-95 that are **NOT** going to the Speedway are encouraged use Beville Road or L.P.G.A. Boulevard.

**Williamson Boulevard:** Williamson Boulevard between Beville Road (SR-400) and West International Speedway Boulevard (US-92) will not be restricted but there will be heavy congestion.

**Richard Petty Boulevard:** Petty Boulevard will not be restricted from Clyde Morris to Midway Boulevard. Normal two way traffic

**On Property Parking :** The only on property parking will be reserved for tower parking only through gate 26. Gate 25 will be closed to all vehicular traffic and accepting pedestrian traffic only. Handicapped parking at turn one plaza, The ISC facility at 92 and Nascar Drive, Volusia Point at 92 and Bill France, and Gate 50 on back side of speedway.

### ***After the Race:***

**Fentress Boulevard:** Race fans leaving the Best Buy parking lots may exit the west gate onto Bayless Avenue to access Fentress Boulevard or Williamson Boulevard.

**Thames Road:** All traffic exiting the Volusia Square Mall will be sent south on Thames to Williamson, where it will be directed south to access the Interstate System.

**L.P.G.A. Boulevard:** Traffic eastbound on L.P.G.A. Boulevard from Speedway Boulevard will experience lengthy delays beyond Champions Drive.

**US - 92:** Westbound traffic on West International Speedway Boulevard desiring to go west should utilize Beville Road to avoid heavy traffic in the vicinity of the speedway.

**I - 95:** It may be necessary to restrict northbound traffic from exiting at L.P.G.A. and SR-40 from I-95. Motorists will be allowed to exit at the next exit, which is US-1 at National Gardens. Traffic wishing to go to Daytona Beach should utilize US-1 southbound. Traffic wishing to go to A1A should take US-1 to SR-40 in Ormond Beach, and go east over the Granada Bridge to A1A. Motorists' wishing to travel west on SR-40 can exit at US-1 and re-enter I-95 and travel south to SR-40.

**Clyde Morris Boulevard:** Northbound Clyde Morris Boulevard will be forced south (left) on Bill France.

### **Sunday - February 23, 2014 (Daytona 500)**

#### ***Before the Race:***

**US-92:** Eastbound vehicles on US-92 from Deland, I-4 and I-95 that are NOT going to the speedway are encouraged use Beville Road or L.P.G.A. Boulevard.

**On Property Parking:** The only on property parking will be reserved for tower parking only through gate 26. Gate 25 will be closed to all vehicular traffic and accepting pedestrian traffic only. Handicapped parking at turn one plaza, The ISC facility at 92 and Nascar Drive, Volusia Point at 92 and Bill France, Gate 50 on back side of speedway, and lot 10.

**I-4:** It is urged that vehicles coming in on I-4 proceed east on Beville Road (SR-400 marked "*To South Daytona*"), then north on Clyde Morris to Petty Boulevard and west on Petty Boulevard to speedway parking areas. Traffic may also be directed to parking lots on the west end of the speedway via Williamson Boulevard from Beville Road.

**Williamson Boulevard:** Williamson Boulevard between Beville Road and West International Boulevard will be restricted. All through northbound traffic from Beville Road (SR-400) will be restricted for event parking from 6:30 a.m. until approximately 10:00 a.m.

**Thames Road:** Thames Road will be restricted to event and Volusia Square Mall traffic only.

**Flea Market:** Those wishing to access the Flea Market should utilize State Road 415, [Tomoka Farms Road], from either Speedway Boulevard or from the south.

***After the Race:***

**Bill France Boulevard:** Bill France Boulevard may be ONE-WAY NORTH from West International Speedway Boulevard to the Mason Avenue intersection. Access on Bill France Boulevard from Mason Avenue to Clyde Morris Boulevard will be restricted.

**Speedway Tunnel Entrance:** Race fans leaving the track via the turn four (4) tunnel entrance will be routed east toward Richard Petty Boulevard. This traffic will continue east toward Clyde Morris Blvd and sent south to access I-4 and I-95 via Beville Road or Dunlawton Avenue.

**Volusia Mall Parking:** Volusia Mall traffic may exit north to Mason Avenue via Bill France Boulevard, which may be ONE-WAY NORTH to Mason Avenue, where traffic may proceed east or west on Mason Avenue. Mall traffic may also exit via the main entrance/exit at US 92. This exiting traffic will be sent east on US 92 and can proceed east to the beachside, or turn north or south at Clyde Morris Blvd, Nova Road or Ridgewood Avenue to access the Interstate system.

**Jimmy Ann Drive:** Jimmy Ann Drive will be normal two way traffic.

**Dunn Avenue:** Dunn Avenue will be restricted to local traffic only between Clyde Morris Boulevard and Williamson Blvd.

**Clyde Morris Boulevard:** South bound Clyde Morris Boulevard will be restricted at LPGA Boulevard. North bound Clyde Morris Boulevard will be restricted at Jimmy Ann Drive. Northbound Clyde Morris Boulevard will be forced south (left) on Bill France.

**Airport Parking:** Race fans using Airport property for parking should exit east, via Richard Petty Boulevard and then south on Clyde Morris Boulevard to Dunlawton for easy access to the interstates.

**Richard Petty Boulevard:** Petty Boulevard may be ONE-WAY EAST to the Clyde Morris intersection. Race fans exiting Petty Boulevard must turn right onto Clyde Morris Boulevard. Central and South Central Florida traffic will be encouraged to continue south on Clyde Morris Boulevard to Dunlawton Avenue. Traffic will turn right on Dunlawton Avenue to access I-95, north to I-4 or south to the Bee-Line.

**Mason Avenue:** Mason Avenue may be ONE-WAY WEST from the Bill France intersection to Williamson Boulevard.

**Williamson Boulevard:** Williamson Boulevard, north of Mason Avenue, may be ONE-WAY NORTH from the Mason Avenue intersection to L.P.G.A. Boulevard. Access to I-95, I-75, I-4, Ocala and US-1 (north) can be reached via Williamson Boulevard. Williamson Boulevard, south of Mason Avenue, will consist of normal north and southbound traffic lanes to Bayless. Williamson, south of Bayless will be closed to southbound traffic. There will be no access to Williamson Boulevard southbound from west International Speedway Boulevard. Williamson Boulevard will be one-way southbound from Gate 40 to Beville Road.

**Fentress Boulevard:** Fentress Boulevard will be normal two-way traffic between Bayless and Mason Avenue. Access to Fentress Boulevard from Speedway Boulevard and Mason Avenue will be restricted to business traffic only.

**Thames Road:** All traffic exiting the Volusia Square Mall will be sent south on Thames to Williamson, where it will be directed south to access the Interstate System

**L.P.G.A. Boulevard:** Traffic eastbound on L.P.G.A. Boulevard from Speedway Boulevard will experience lengthy delays beyond Champions Drive.

**US - 92:** Westbound traffic on West International Speedway Boulevard desiring to go west should utilize Beville Road to avoid heavy traffic in the vicinity of the speedway.

**I - 95:** It may be necessary to restrict northbound traffic from exiting at L.P.G.A. and SR-40 from I-95. Motorists will be allowed to exit at the next exit, which is US-1 at National Gardens. Traffic wishing to go to Daytona Beach should utilize US-1 southbound. Traffic wishing to go to A1A should take US-1 to SR-40 in Ormond Beach, and go east over the Granada Bridge to A1A. Motorists wishing to travel west on SR-40 can exit at US-1 and re-enter I-95 and travel south to SR-40.

## **SPECIAL INFORMATION**

Non-race related residents and or visitors wishing to access the greater Daytona Beach area are encouraged to use State Road 44, Dunlawton Avenue, LPGA Boulevard or State Road 40 for east – west travel. Other non-race related east – west traffic with in the City desiring to avoid race traffic should use Beville Road between Pelican Bay and Ridgewood Avenue and Mason Avenue between Clyde Morris Boulevard and Ridgewood Avenue.

Non-race related residents and or visitors traveling north – south through the greater Daytona Beach area are encouraged to use Atlantic Avenue, Ridgewood Avenue or Nova Road.

On race days, those persons en-route to the Speedway from the beachside are advised to cross the Seabreeze Bridge and use Mason Avenue for quick access to the races. Motorists desiring to reach the Airport or area hospitals from the north or south



should use Nova Road or Ridgewood Avenue then west on International Speedway Blvd.

Under City of Daytona Beach Ordinance 86-42, "camping" will not be allowed within the City Limits in any areas not properly licensed for the purposes of "camping". Camping is defined as: (1) Sleeping or otherwise being in a temporary shelter out-of-doors; or (2) Sleeping out-of-doors; or (3) Cooking over an open flame or fire out-of-doors.

At no time are roadway medians, right-of-ways, parking lots, power-line trails, wooded areas, or non-licensed private properties open for camping. This will be strictly enforced throughout the City, resulting in fines, vehicle/camper removal, and possible arrest.
