

EXECUTIVE ORDER NO. 6 OF THE MAYOR OF THE CITY OF DAYTONA BEACH
EXTENDING THE LOCAL STATE OF EMERGENCY DUE TO COVID-19

WHEREAS, Governor Ron DeSantis issued Executive Order 20-51 on March 1, 2020, authorizing and directing the State Health Officer and Surgeon General to declare a public health emergency in the state of Florida as a result of the COVID-19 outbreak; and

WHEREAS, the City's Comprehensive Emergency Management Plan, adopted pursuant to Ch. 252, Florida Statutes and City Resolution No. 19-131, provides that the Mayor may declare a local state of emergency for increments of seven days subject to City Commission approval and endorsement; and

WHEREAS, due to the COVID-19 pandemic, I, as Mayor of The City of Daytona Beach, issued a Declaration of a Local State of Emergency dated March 13, 2020, and an Amended Declaration of a Local State of Emergency and Executive Order dated March 17, 2020, for an initial seven day period; and

WHEREAS, the City Commission has affirmed, endorsed, and extended the Local State of Emergency for successive additional seven day periods, most recently by Resolution 202-98, extending the Local State of Emergency due to COVID-19 until midnight on May 12, 2020; and

WHEREAS, as the Mayor of The City of Daytona Beach, I issued Executive Order No. 5 further extending the Local State of Emergency due to COVID-19 for an additional seven day period ending May 19, 2020, pursuant to authority provided in Resolution No. 2020-96; and

WHEREAS, COVID-19 continues to be a threat to the public health of an unknown duration; and

WHEREAS, as the Mayor of The City of Daytona Beach, I have determined that an extension of the Local State of Emergency for an additional seven day period ending at midnight, May 26, 2020, is necessary to protect the health and welfare of the citizens in the City due to

WHEREAS, pursuant to City Resolution No. 2020-96, during the Local State of Emergency, emergency measures may be exercised as necessary as set forth in Section 2-3, City Code, and the Mayor shall have authority to execute executive orders as necessary to aid in their appropriate implementation; and

NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF THE CITY OF DAYTONA BEACH:

SECTION 1. The Local State of Emergency is hereby extended, and shall remain in effect until midnight on May 26, 2020, unless sooner terminated or extended by order of the Mayor or City Commission action.

SECTION 2. Additional emergency measures set forth in Section 2-3, City Code, may be implemented as necessary.

SECTION 3. This Executive Order shall take effect immediately upon its issuance.
