<p>[1] Commercial and / or Non-residential applicants with establishments that have service requirements as determined by the City that require the installation of or is receiving potable water service by a domestic meter with a diameter greater than four (4) inches, shall pay a capacity facilities fee equal to the greater of i) the minimum amount of ERCs allocated per meter as provided in this section or ii) the per gallon capital facilities fee rate applied to the daily water and / or daily wastewater demand, expressed in gallons per day, for the applicant. The applicant shall submit an estimate of average daily water usage and wastewater flow requirements expressed in gallons as prepared by a professional engineer licensed in the State of Florida. The City shall review the estimate and will have final discretion as to the acceptance or rejection of such estimates. Acceptance of such estimates may be granted subject to monitoring.</p>

STORMWATER MANAGEMENT RATES PER ORDINANCE 98 101-107

It is necessary to provide storm water drainage facilities throughout the city in order that the health, safety, and welfare of the city's inhabitants may be protected. It is the intent and purpose of this article to provide authority to levy fees against all owners, tenants, or occupants whose property impacts the storm management facilities or who enjoy benefits therefrom and provide the city with a rational means for imposition of such fees to be used for the construction of improvements and extension of the facilities, maintenance, and administration.
