Program Overview

The American Rescue Plan Act of 2022, Pub L. No. 117-2, provides critical and unprecedented support to children, families, and communities in response to the COVID-19 pandemic and resulting economic downturn, who are low to moderate income households. The City of Daytona is a recipient of Coronavirus State and Local Fiscal Recovery Funds derived from the Rescue Plan Act.

Program Purpose

An Initiative aimed to provide financial relief to residents for landscaping and beautification improvements, located in the Community Redevelopment Areas. Types of improvements will include grass cutting, sodding, mulching, pruning, planting of trees, flowers and grass. Removal of weeds, junk, debris, trees, and tree limbs. The maximum grant award will be \$1,000 per single family residence.

Program Eligibility Criteria

- Proof of homeownership (homestead exemption, warranty deed etc.);
- Must be your primary residence
- Annual gross income must not exceed the following (HUD qualified income guidelines).
- Limited to one property per owner and must be owner occupied.
- Assistance will be provided on a first come first serve basis.
- Assistance only available for single-family households located in Daytona Beach.
- Low to moderate household income

Timeline

- Applications are accepted on a rolling basis until funding is depleted.

Once applications have been received, a representative will contact applicant for a site visit.

Essential Documentation Needed

- Proof of applicant homeownership (i.e., current year homestead exemption, property taxes or mortgage statement);
- Proof of home occupancy (utility bill or mail received at property address);
- Proof of household income for the last 3 months for all household members (ex: pay stubs, profit and loss statement if self-employed, benefit award/social security letter, pension letter, unemployment, cash assistance etc.);
- Recent two (2) month bank statements or financial histories;
- Government issued picture identification (ID) for all household members ages 18 or older;
- If approved, the applicant must sign the commitment letter, the permission to perform Property Assessment and Release of all Claims, and the Agreement for landscaping improvements.
